PF-10 SFES Systems incorporate a HydroBlend[™] cartridge that is specifically designed to work with standard prefilter heads.

HydroBlend[™] is utilized in a solid block cartridge form. A predetermined amount of surface area of the cartridge is exposed to the water for predictable treatment periods.

Sequesters scale causing minerals making them more soluble in water thus reducing the chances of precipitation as hard mineral scale.

Provides corrosion control by forming a protective micro-thin lining on wetted surfaces

Helps soften and remove existing mineral scale deposits

Installation Summary

Place system in an accessible location for ease of filter replacement

Ensure that the system is mounted vertically with a minimum of 2" clearance from the bottom of the system to allow for filter replacement

Do not over tighten fittings

Operating Tips

Replace cartridge when the product media fully dissolves to the bottom of the cartridge.

Feed holes in cartridge may get clogged. If so, remove cartridge from housing and clean out debris with paperclip.


